***Special awards.***

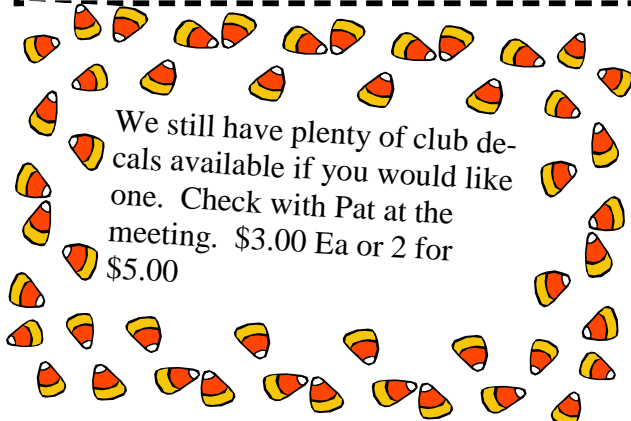

## **RELAY FOR LIFE**

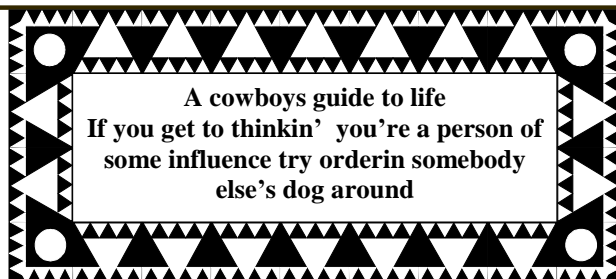
I don't know how many of you are familiar with the American Cancer Society Relay for Life held each year in Filer.
