

Letter from your President:

At last month's MVATVR club meeting it was mentioned that the sign project, which several members of the club have been involved in, had come to a halt because the local Forest Service office ran out of signs and had no money to buy more. One of our members asked that the Board of Directors look into the club financing the signs and report back to the membership on our decision. We did discuss it at our last board meeting and decided to delay the decision for a while due to the riding season coming to an end in the hills and to give the Forest Service a chance to rectify the situation. The decision was the right one, as the sign issue has already been resolved by the Forest Service. We must remember we are already paying for those signs. We pay income taxes that fund the Forest Service. We pay gas taxes on fuel that is used off-road.

Thankfully both our state government and the Federal government have provisions for our gas tax to be used for projects that will benefit the ORV community. Grant money from these programs is available for agencies to acquire needed funds for projects that will benefit us. Signs would fit in this category. In the past we have provided input to the Forest Service regarding projects we would like to see happen. We have also given our support for the grant requests. In 2014 there will be \$800,000.00 state money available and 5 million dollars of Federal money available to applying agencies. Financially our club may not contribute a lot to Forest Service projects but we contribute quite a bit in volunteer hours. This year the amount of volunteer time this club contributed would amount to several thousand dollars. We also provide and fund the food at National Public Lands Day. These are some of the ways we give back and do our part to help make ATV riding better for all.

The request that we donate money for the signs got me thinking about our club, and its purpose.

Let us return to the year 2007. The Forest Service had made the decision to adopt a "closed unless open", designated trail system for all National Forest Land. Locally we did not have a strong unified voice advocating for the ATV community. I personally felt the need for an ATV club was paramount if we were to be represented in the decision making process of deciding what was going to be open and what was going to be closed. On January 1, 2008 the Magic Valley ATV Riders, Inc. was born.

By having a local club we are able to network with other clubs and national organizations to present an even stronger voice. Have we made a difference? Yes! You are currently riding many trails that probably would have been closed had it not been for this club. The benefits of having a rather large club such as ours are numerous. We have the opportunity to meet and socialize with folks of like interests. We have the opportunity to ride new areas.

We have the opportunity to keep informed about products, events and changes on the subject of ATV's. These are the benefits of having and joining our club. With that being said we must always remember that the mission and purpose of this club is to do whatever we can to insure that current and future generations will have a place to ride. Without a place to ride, all the benefits do not matter.

There is an old saying that "Freedom is not free" and this is very true in our case. There are people, organizations and agencies that would prefer that ATV's go away on public land. Unfortunately many of these folks are well organized and well funded and will not hesitate to file suits and appeals and use litigation to accomplish their goals.

Fighting to keep our land open is not cheap. MVATVR contributes every year to organizations such as Blue Ribbon Coalition, Idaho Recreation Council, and Idaho State ATV Association to help them with the very expensive job of keeping public lands open to the public.

One of the upsides of having a large successful ATV club such as ours is that we have a fairly healthy treasury. The question has been asked why do we have this money just sitting in our checking account. Why not spend it?

As I said before we contribute every year to organizations that help us and we will continue to do so. Litigation is not cheap. The money sitting in our checking account is our war chest. We need to have that money available to combat a threat to our access of public land.

Please remember your officers and board of directors are here to serve you and are always willing to listen to what you have to say. Please do not hesitate to contact any of the board members with questions or concerns.

We currently have a very good board of directors. They are excited about being on the board, and are bringing new ideas to our club. They have all decided to continue as board members in 2014 if you wish to have them do so.

TRAIL DIFFICULTY GUIDE

Level 1, Beginner:

Gravel or dirt surfaces that are relatively flat and wide. Generally wide enough for an ATV to pass a fullsized vehicle. May be dusty but are relatively smooth with no rocks or roots protruding more than three inches above the surface. Ride distance will be short, speeds very slow.

Level 2, Advanced Beginner:

Mild ups and downs, some narrow, mild rock, mostly roads and jeep trails, minor off camber. Two-wheel drive ok.

Level 3, Intermediate:

Loose gravel, sandy, rocky or rutty surface. May have short sections that are narrow. Can have blind turns, switchbacks, steep or roller coaster grades, some off-camber side hills, minor drop-offs, ruts and frequent changes in riding surfaces. Occasional obstacles may strike the frame. Four-wheel drive may be needed depending on conditions. Pace of ride will be a little faster, distances and length of ride will be longer.

Level 4, Advanced Intermediate:

Rocky surfaces, sharp turns, switchbacks, steep grades, narrow passages, low overhangs, ledges and large rocks. Can be slippery and muddy when wet. May have tree stumps, limbs or other debris. Machines with low ground clearance may strike or high center on obstacles. Four-wheel drive highly recommended.

Level 5, Expert:

Very rocky, steep, off camber, high water crossings, large ruts. Large obstacles in trails, narrow with big drop offs. Four-wheel drive required, may need winch.
