Some of these abuses, and not limited to, are trespassing and littering on private lands, and causing unsightly destruction. Accessing our public lands often relies on crossing private lands. We are fortunate in several areas of our state where established access is already in place. However, in some areas access across private lands is a courtesy of the landowner. As responsible users we appreciate all private landowners who grant access across their land. We, as responsible users, must set the example to recreate properly and follow "Stay on Trails" philosophy. We should acknowledge other users who also set the positive example of properly motorized use and point out those who are not following proper access and trail etiquette. If we as responsible users do not educate others on proper motorized use, we risk losing not only access to, but the use of both private and public lands. Bottom line is we can work with all landowners to ensure access is maintained to private lands for all users.

As January is coming to a close, that means we are getting closer to spring. Keep checking your emails as you never know when the weather will give us an opportunity to go for a ride.

Public Lands

am sure many of you are aware Pat and I are spending the winter in sunny Arizona. Having never been a big fan of snow and cold we are really enjoying winter this year. Currently the daytime temps are hitting the low 70's. I know, tough to

handle but we are trying our best to cope. We have been doing quite a bit of riding; our RZR has over a thousand miles more on the odometer than it did when we arrived. Desert riding



here is quite different than Idaho. Much of the area has been mined extensively with over 14,000 mining claims in the area. The country is quite rugged with lots of elevation changes, sand washes are everywhere. Being mining country it is very rocky with lots of little rocks, big rocks and steep climbs. Almost daily we get to hear the sound of freedom, as F-18 fighter jets use this area for low level training.

Because of the mining activity, there are many roads, if you want to call them that. Most are un-maintained BLM roads that have become more like trails than roads. Because of the rocks, the steepness, and the type of soil here, heavy rains cause lots of washouts and ruts. All of this makes for great OHV riding. You will see all kinds of OHV's here and lots of them. OHV recreation is a big part of the local economy. This brings me the point of this article.

A few years ago the BLM began the task of inventorying and designating roads as part of travel management planning in this area. It very quickly became apparent that the BLM was following their normal process of closing a very high percentage of the roads as part of their so-called management plan. OHV users were very upset and made their feelings known, both as individuals, clubs and large organizations. The OHV community said if these closures happen, we will have no reason come here.

Local businesses and community leaders realized they needed get involved in the planning process. They got officials from all levels in Arizona involved in persuading the BLM to leave the desert open and available to the OHV



community. The BLM seems to be listening; the areas that have completed travel management have very few closures.

This is why it is so important for clubs and groups to make their needs known to everybody from city to county to state and federal officials. Do not hesitate to contact your county commissioners and elected state and federal officials with your thoughts. It is also imperative that we have a strong unified voice. Organizations like MVATVR, Idaho ATV Association, Idaho Recreation Council, Blue Ribbon Coalition and Mountain States Legal Foundation all play a part in keeping public lands open to all users. I would encourage supporting these organizations and others who believe our public land should be for everyone, and not divided up into segregated user areas. We are very lucky to have great folks heading up MVATVR, but they cannot do it alone, they need your help. If you care about having places to ride, please volunteer when you can.


OHV Sticker Reminder

They cost \$10 per vehicle. Without the pass, it costs \$5 per vehicle to enter all the parks I looked at.

BLM Closure

The Burley Bureau of Land Management (BLM) Field Office will implement a seasonal road closure Jan. 16 to March 15 in the South Hills area.

This closure, which has gone into effect each

winter since 2000, is designed to prevent resource damage and to protect crucial mule deer winter range and sage-grouse habitat. Signs have been posted in the area



notifying the public of the closure, and gates have been installed to prevent trespass.

The following roads, as well as any twotracks or trails tied to these roads, will be closed to motorized travel from Jan. 16 to March 15, 2020: Dry Creek, Cherry Spring, Indian Springs (Closure begins 1.5 miles south of Foothills Road) and North Cottonwood Creek.

The seasonal closure applies to all motorized vehicles except those specifically authorized to access the area. The area is open to the public for non-motorized use.

Instant Pot Baked Bean

One more recipe. At the banquet, if you had the baked beans that were right by the meat, here is the recipe.

1 pound of bacon sliced into small pieces, cooked, and then drain the fat. Put the bacon in the Instant Pot.

2 cans each of the following beans, drained: Cannellini, black, red, pinto, kidney, and Butter Beans (the big ones).

About half a bottle of Sweet Baby Rays BBQ sauce and a cup or so of brown sugar. Stir together.

Cook in the Instant Pot for 45 minutes and then eat.

Obviously, if you want less, use one can of each type of beans. Use the same amount of bacon

RotopaX

ow many of you have a RotopaX fuel storage jug on your machine? I do, and I know many of the rest of you do as well. Well, did you know that RotopaX is based in Woods Cross, Utah (down by SLC).

On occasion I check out RotopaX's website to see what they have in their <u>blemished products</u> <u>page</u>. They sell anything that came out of the mold with scratches or small molding defects (nothing in the neck) that will not affect the ability to hold fuel safely and they only carry a one-year warranty instead of the regular 10-year warranty.

They had a four-gallon pack on for \$71.95 (regularly \$99.95) so I ordered one. When it arrived three days later (ordered it on the weekend), I didn't find any problems with it, other than some black marks as shown, which wiped right off. Other than that, they look like normal fuel jugs to me.





Right now they have everything from 1gallon jugs for \$35.95 all the way up the big 4 gallon jugs available.

For those in the market for a fuel jug, this is a good way to augment your fuel capacity to allow you to not be as nervous on those longer rides we all like to go on!

As I was looking around on their website, I noticed that they have a new product coming out soon that is designed for side by sides. It is called the RollpaX and sells for \$179.95. It holds 1½ gallons and mounts on one of the roll bars on your machine. Although the price sounds high, it comes with all the hardware to mount to the roll bar tube on your machine and has a pretty cool looking clam shell clamping system.

The mounts are available in both $1\frac{3}{4}$ " and 2" tube sizes, as well as a flat mount if you want to mount it to a flat surface.

For those that want to use it to carry water, they come in white for \$149.95. On their website, they state the white ones are made of food grade plastic and are not recommended for gas.

On their website they say that these will be available by February 1st (hopefully by the time you are reading this). If anyone buys one, please let me know and we will get a product review and some pictures in an upcoming newsletter.

Local Manufacturers

n the previous article, we learned that RotopaX is based in Utah, not far from Salt Lake City. For those not aware, there are several other companies that make ATV\UTV accessories fairly close to us as well.

Razorback Offroad is based in

Mountain Home, Idaho. They manufacture cargo racks, roofs, windshields, rear windows, and several other accessories for a collection of different ATV's and UTV's.



Another company I stumbled upon when

looking online at accessories is <u>Titan All Terrain</u> based out of Idaho Falls, Idaho. Their parent company is Titan Fuel Tanks, a well-known company



that makes larger replacement fuel tanks for vehicles.

Although not released yet, they are in the process of making a in-bed fuel tank for UTV's. They will hold 12 gallons of fuel and 4.5 gallons of dry storage. It will come with a 12-volt fuel pump and nozzle. According to their website they are accepting pre-orders for right at \$500. It looks like the regular price will be around \$600.



<u>Rocky Mountain ATV</u>, a well-known dealer in Payson, Utah, is also making a ton of ATV and UTV accessories. They make windshields, roofs, tires, and a bunch of other stuff.

Polaris General Build

This past December when I was elk hunting with friends, we put my friend's 4 seater Polaris General that he bought from Young Powersports to good use and hauled out a good number of elk that are currently resting comfortably in various freezers.

Just before one of the hunting trips, Shane and I were antelope hunting and hit a rock and put a small crease in his A arm. Then, one of the elk trips, we tore part of the skid plate off unloading it from the trailer, and on another trip, we ripped the sidewall out on one of the tires.

After things were all said and done with hunting, Shane busted out the credit card and ordered a whole pile of accessories to go with all the accessories he already installed.

One of the items he ordered was a 3" lift kit from <u>Super ATV</u> for \$250. It came with a bracket for the front that mounted the front shocks at a more vertical angle which allowed the front tires to go up 3". The rears were lifted with a combination of a set of brackets and a stiffener bar that did the same for the rear shocks. Page 7

He also ordered a set of <u>High Lifter</u> forward and rear control arms for \$440. They claim they are twice as strong and are arched to allow more clearance from those pesky rocks we like to ride on.



From Super ATV, he ordered a full set of 1 1/2'' wheel spacers for \$190.



From <u>Factory UTV</u> he ordered their Ultimate Half Inch UHMW Skid Package for just under \$1,400.00



From Amazon, he bought some more LED spot lights to augment the 42" LED bar he already has mounted.

As we have been installing everything over the last couple weeks, we ran into a few snags.

One, the control arms did not come with bushings, as we tried to remove them from the stock control arms, we discovered that they are nonremovable which meant that we had to order some which put the install behind.

Two, the lift kit needed a bit of "persuading" to install via some large pry bars due to the metal warping a bit during the welding process at the factory.

Three, the rock sliders as part of the skid plate package needed a bit of modification because he already has steel tube rock sliders attached to the machine.

Four, the front control arms are arched, and the control arm guards that came with the skid plate are not. We are in the process of trimming, heating, and bending them to conform to the aftermarket skid plates.

After much work, we finished up the machine. Shane is going to make one more change in the coming months, and that is to get some 30" tires (probably Tusk Terrabites) in the coming months when his checking account is replenished.

Things to Check

So, when is the last time you checked all the junk you have stuffed in your machine? Stuff like zip ties, tire plugs, glue, straps, and all that other good stuff?

As previously mentioned on my elk hunt, one of the tires got a nice big slash in the inside sidewall.

Fortunately, Shane had a nice spare tire and wheel mounted on the General, along with a car jack he scored from the junk yard.

After jacking up the machine, we attempted to remove the lug nuts. See the word attempted up there? That's what we mean.....

It seems that the included factory lug nut wrench that Polaris

included in the machine is not only made in China (we assume) but made out of the cheapest grade of what passes for steel possible. As we tried to loosen the nuts, the metal twisted, and twisted more.

Fortunately, we had a large pair of channel locks with us, and by using the channel locks on the wrench, along with some careful twisting of the wrench, we finally loosened the nuts enough to get them off.

Now, Shane has a handy dandy collapsible lug nut wrench in the machine for the next time it needs to be used. WorkPro universal wrenches are \$14.99 on <u>Amazon</u>.

So, since we are in the "off season", you might want to pull your rig in the garage and go though everything and make sure all your stuff is good to go.

Tusk Terrabite Tires

Just a heads up. Rocky Mountain ATV has had their Tusk Terrabite 8 ply tires out for a while, and several members have been using them on their machines with success.



They have recently added another tire to the Terrabite line. They are called Tusk Aramid Terrabite. These ones have Kevlar belts instead of steel belts.

For those that are not aware, if you buy a radial tire, the steel belts to not extend into the side walls. The Aramid version has Kevlar belts that extend down into the bead which supposedly protects your sidewall better.

As a price comparison, the regular version in a 27x9x12 is \$104.50 and the Aramid version in that same size is \$124.99

Trail Difficulty Guide

Evel 1 - Beginner: Gravel or dirt surfaces that are relatively flat and wide. Generally wide enough for an ATV to pass a full-sized vehicle. May be dusty but are relatively smooth with no rocks or roots protruding more than three inches above the surface. Ride distance will be short, speeds very slow.

Level 2 - Advanced Beginner: Mild ups and downs, some narrow, mild rock, mostly roads and jeep trails, minor off camber. Two-wheel drive ok.

Level 3 - Intermediate: Loose gravel, sandy, rocky or rutty surface. May have short sections that are narrow. Can have blind turns, switchbacks, steep or roller coaster grades, some off-camber side hills, minor drop-offs, ruts and frequent changes in riding surfaces. Occasional obstacles may strike the frame. Four-wheel drive may be needed depending on conditions. Pace of ride will be a little faster, distances and length of ride will be longer.

Level 4 - Advanced Intermediate: Rocky surfaces, sharp turns, switchbacks, steep grades, narrow passages, low overhangs, ledges and large rocks. Can be slippery and muddy when wet. May have tree stumps, limbs or other debris. Machines with low ground clearance may strike or high center on obstacles. Four-wheel drive highly recommended.

Level 5 - Expert: Very rocky, steep, off

camber, high water crossings, large ruts. Large obstacles in trails, narrow with big drop offs. Four-wheel drive required, may need winch.



Club Rules

1. Pets should be kept on a leash of no longer than 6 feet during any rides, campouts or other MVATVR events. Please be a responsible pet owner and respect the rights of others.

2. Idaho State Law states that being under the influence and/or consuming alcohol or illegal drugs while operating an OHV is illegal and therefore will not be tolerated by MVATVR, Inc.

3. Generator use should be with consideration for others in camp and a recommended quiet time from 10:00 PM to 6:00 AM needs to be observed.

4. By operating your machine in a safe responsible manner, waiting at intersections and corners, you can insure that fellow riders will not be left behind and everyone will have an enjoyable ride.
