#### **Trail Difficulty Guide**

**Level 1 - Beginner:** Gravel or dirt surfaces that are relatively flat and wide, generally wide enough for an ATV to pass a full-sized vehicle. May be dusty but are relatively smooth with no rocks or roots protruding more than three inches above the surface. Ride distance will be short and speeds will be slow.

**Level 2 - Advanced Beginner:** Mild ups and downs, some narrow, mild rock, mostly roads and jeep trails, minor off camber. Two-wheel drive ok.

Level 3 - Intermediate: Loose gravel, sandy, rocky or rutty surface. Also, May have short sections that are narrow. Trail can have blind turns, switchbacks, steep or roller coaster grades, some off-camber side hills, minor dropoffs, ruts and frequent changes in riding surfaces. Occasional obstacles may strike the frame. Four-wheel drive may be needed depending on conditions. Pace of ride will be a little faster. Distances and length of ride will be longer.

**Level 4 - Advanced Intermediate:** Rocky surfaces, sharp turns, switchbacks, steep grades, narrow passages, low overhangs, ledges and large rocks. Can be slippery and muddy when wet. The trail may have tree stumps, limbs or other debris. Machines with low ground clearance may strike or high center on obstacles. Four-wheel drive highly recommended.

**Level 5 – Expert:** Very rocky, steep, off camber, high water crossings, large ruts, and obstacles in trails. Can be narrow with big drop offs. Four-wheel drive required, may need winch.

#### 1. UPDATE ON LAVA RIDGE WIND PROJECT



Dan Sakura and Janet Keegan were guest speakers at the May 18 Board Meeting. They spoke about the Lava Ridge Wind Project and its implications for the whole area. A meeting was also held at the Jerome Public Library on May 19 in which 200 plus people showed up in opposition to the Lava Ridge Project. Senators Risch and Crapo, along with Congressman Simpson, had representatives from their offices at the meeting. This single project will be locking up about 72,000 acres of public access.

The BLM will host a field trip on June 15, 8 AM to 5:30 PM and the public is invited. You will need to provide your own transportation (high clearance vehicle, ATV/UTV). The tour will begin and end at the BLM District Office, 2878 Addison Ave. Twin Falls. A comment period will be held from 4:45 to 5:15 PM. LS Power has scheduled a community meeting on June 10 & 11 on the Salmon Falls Project. I believe you can find more info on the Magic Valley Energy website.

\*There are four projects planned that will encompass about 300,000 acres. The power that is generated is planned to go to L.A. California.
